## Terms and Conditions

### Application

The application for CASHWALK is only valid if the provided information is correct.

Each Startup can only apply once. If multiple applications are handed in only the first one will be considered.

After the deadline of the application process, the LMU Entrepreneurship Center and the German Accelerator (in the following LMU EC & GA) select 50 startups that will be invited to pitch at the event. The invitation is sent to the email address provided in the application.

The closing date of the application the 8<sup>th</sup> of August, 2017 at 11.59 pm. The organizer maintains the right to accept applications after this.

### Pitch Decks

Each participant is responsible for the information included within your pitch deck. It is assumed that you are the sole owner and holder of all rights of use and exploitation.

### Privacy Protection

Each participant agrees that the data within his/her application (including, but not limited to, information such as startup name, pitch deck and sector) can be used for the following purposes:

- The top 100 startups will get the chance to send us a second pitch deck which will be forwarded to selected investors
- Market research for internal purposes
  - Advertising
  - Sending information
  - Compilation of publication (this will include a booklet with a short description of your startup, pictures, your homepage and your contact address, that will be handed out at the event)

The applicant agrees to receive and/or accept electronic newsletters and other information from the LMU EC & GA.

### Event

If the applicant is invited to the event, he or she is obliged to pitch or let the LMU EC & GA know that they are not coming before 26<sup>th</sup> of September 2017. Due to the exclusivity of our event, we will charge an administrative fee of €500.00 + VAT in case you confirm your participation, but do not pitch on 10<sup>th</sup> of October 2017. The invitation to join the event is valid for three team members at a max.

If the event is canceled due to any reason, the invitations are no longer valid.

Within the framework of CASHWALK, audio, picture and video recordings of the individual participants and the event will be created free of charge. All participants of CASHWALK agree that the recordings and images/photographs acquired at the event can be used free of charge for press reports, advertising poster, calendars, brochures, commercial products and manuals, and on LMU EC & GA websites and third party websites (e.g. right of use for YouTube, Vimeo, Facebook, Twitter, etc.) and these rights of use may be given to third parties by LMU EC & GA, both free of charge and also against payment.

### Liability

The LMU EC & GA are not responsible for personal items that are lost or damaged during CASHWALK.

Each participant must make provision for their own insurance. There is no coverage through LMU EC & GA. Except for personal injury, the LMU EC & GA are not liable for minor cases of negligence.

### Miscellaneous

Court of Jurisdiction is the relevant court in 80539 Munich. Contractual relationship with the LMU EC & GA are subject exclusively to German law.
